This has reference to Appeal dated 19-04-2023 filed by Rajkiya Engineering College Banda, Atarra, Banda-210 201, Uttar Pradesh against non-accreditation to the UG Information Technology and UG-Mechanical Engineering programs of your Institution communicated vide NBA's letter of even number dated 14-02-2023.

The Appeal has been considered in NBA. Represntattives of the Insitution also presented the case before the Appellate Committee at its meeting held on 13-12-2023. The recommendation of the Appellate Committee has been considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the programs is given in the table below:
